Cooperation in Development of Boiler Energy Service

Tokyo Gas Engineering Solutions Corporation ("TGES"), PT. Mitsubishi UFJ Lease & Finance Indonesia ("MULI"), PT. Miura Indonesia ("MIURA"), and PT. Energasindo Heksa Karya ("EHK") mutually agreed and signed the Memorandum of Understanding ("MOU") for the purpose of developing boiler energy service (the "Service") in Indonesia. The MOU intends to cooperate with each other for the purpose of developing and exploring the potential industrial customers related to the Service for industrial customers and accumulating knowledge and skills of the Service.

The Service provided the customers is as follows: (1) Installing highly efficient boilers and their auxiliaries with no capital expenditure utilizing finance lease; (2) Providing comprehensive maintenance for highly efficient boilers and their auxiliaries during the period of the agreement; (3) Supporting energy management of customer's facility by remote monitoring and reporting; and (4) Providing efficiency guarantee of boilers.

This collaboration intends to promote in advanced and aims to efficient utilization of energy-related to filling facilities of natural gas through the collaboration with TGES who has a knowledge of sales activity and operational management through lots of experience in Japan, MULI has a knowledge of leasing and financing to energy sectors, MIURA has a knowledge of boiler management and steam utilization, and EHK who will develop the natural gas supply business for industrial customers in Indonesia.

We will commence the Service with the first customer in 2019. Through this Service, we, TGES, MULI, MIURA and EHK will contribute to the growth of industry and zero environmental footprint in Indonesia.


